GRO-POWER[®] HI-NITROGEN 14-4-9 also contains humic acids, which may increase micronutrient uptake.

After GRO-POWER[®] HI-NITROGEN 14-4-9 is applied and watered thoroughly; there is a steady release of nitrogen.

WATER THOROUGHLY AFTER APPLYING FERTILIZER

Check with your Nurserymen or spreader manufacturer for recommended spreader settings.

The setting on spreader may vary due to the age and use; check the settings carefully. Broadcast spreader rates are also dependent on the speed the spreader is pushed. Carefully calculate the area to be fertilized and make certain the proper number of pounds is being applied to area. **CAUTION:** Close spreader opening when turning, stopping and filling spreader.

IMPORTANT NOTE: This product is NOT recommended for Dichondra lawns or for use in soil preparation.

Since soil conditions, usage and level of maintenance desired may vary, GRO-POWER[®] HI-NITROGEN 14-4-9 can be used effectively in conjunction with other GRO-POWER[®] products (GRO-POWER[®] and GRO-POWER[®] PLUS). Check with your Nurseryman.
